RACHAEL CLARK, MD, PhD, ASSOCIATE PHYSICIAN, BRIGHAM AND WOMEN'S HOSPITAL, ASSISTANT PROFESSOR OF DERMATOLOGY, HARVARD MEDICAL SCHOOL

Rachael A. Clark, MD, PhD grew up in Washington State and did her undergraduate work at Caltech, majoring in both Biology and Chemistry. Upon telling her faculty advisor that she wanted to go to medical school, he said, "I have four years to change your mind." She then entered the MD/PhD program at Harvard Medical School and did her PhD work in the laboratory of Timothy Springer, studying the migration of T cells in secondary lymphoid organs. Initially convinced that she wanted to become an oncologist, she changed her mind after encountering the likes of Rob Stern, Dick Johnson, Harley Haynes and Tom Kupper. These encounters convinced her that dermatology was home to the most interesting people of any specialty and also that it represented a unique opportunity to study immunology in human beings. She did her Dermatology Residency in the Harvard Combined Program and then completed a postdoctoral fellowship with Tom Kupper at Brigham and Women's Hospital. She stayed on to become junior faculty at Brigham and Women's Hospital and currently functions as a dermatologist and immunologist, seeing patients for one day each week and spending the rest of her time running a laboratory that studies the biology of T cells in human skin. She is the recipient of multiple research grants including an NIH R01, a Damon Runyon Clinical Investigator Award, and New Investigator Awards from the Cutaneous Lymphoma Foundation and the Scleroderma Foundation. She received the Brian O'Dell Memorial Research Award from the Leukemia & Lymphoma Society and was elected to membership in the American Society for Clinical Investigation in 2011.

MARGARET TUCKER, MD, NATIONAL CANCER INSTITUTE

Dr. Margaret Tucker is director of the Human Genetics Program at the National Cancer Institute (NCI), Division of Cancer Epidemiology and Genetics. Dr. Tucker received her MD from Harvard Medical School and completed training in internal medicine and medical oncology at Stanford University Medical Center. In over 20 years at NCI Dr. Tucker has led the Institute's research program on familial cancers, the etiology of melanoma, and multiple primary cancers. Her research team and collaborators identified the first major susceptibility genes for melanoma. Dr. Tucker and her team published a melanoma atlas, created training videos to teach doctors how to examine high-risk families, and developed the first calculator to estimate an individual's risk of developing melanoma.

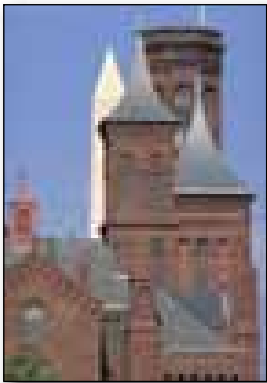

SHEILA P. BURKE, RN, MPA, FAAN

**Senior Public Policy Advisor; Baker, Donelson, Bearman, Caldwell & Berkowitz, PC
Faculty, John F. Kennedy School of Government, Harvard University**

Sheila P. Burke is a Faculty Research Fellow at the Malcolm Wiener Center for Social Policy and a member of the faculty at the John F. Kennedy School of Government at Harvard University. She is also a Senior Public Policy Advisor, Baker, Donelson, Bearman, Caldwell & Berkowitz. She is a Distinguished Visitor at the O'Neill Institute for National and Global Health Law, Georgetown University Law Center and a Research Professor at Georgetown University's Public Policy Institute.

Ms. Burke joined the Smithsonian Institution in 2000 as Under Secretary for American Museums and National Programs and in 2004 became Deputy Secretary and Chief Operating Officer, a position in which she served until September 2007. The Smithsonian Institution is the world's largest museum and research complex, consisting of 19 museums and galleries, the National Zoological Park and nine research facilities. It has more than 5,000 employees, including 500 scientists, and annually accommodates approximately 23 million visitors. As Deputy Secretary, Ms. Burke was responsible for all financial and administrative activities of the Smithsonian, including its facilities and engineering, human resources, information technology, communications and government relations, as well as the policies, objectives and staffing of ten of its museums, centers and offices including the National Museum of American History, the National Museum of the American Indian and the National Museum of African American History and Culture. She also assisted in the management of the Institution's 35 Museum and other Advisory Boards as well as major donor relationships and dealt regularly with the Smithsonian's governing body, the Board of Regents.

From 1996 to 2000, she was Executive Dean and lecturer in public policy at the John F. Kennedy School of Government at Harvard University. The Executive Dean is the School's Chief Operating Officer with management and oversight for the Degree Programs, Executive Education, Financial Services, Information Services, Human Resources, Communications and Facilities and Services. She also taught classes on health and government policy in the undergraduate, graduate and executive education programs.

Ms. Burke was Chief of Staff to Senator Bob Dole, from 1986 to 1996, when he was Senate Minority and then the Majority Leader. In 1995, she was elected as Secretary of the Senate, the chief administrative officer of the U.S. Senate. Starting as a member of the staff of the Senate Finance Committee in 1978 she was responsible for legislation relating to Medicare, Medicaid and other health programs. Ms. Burke became Deputy Staff Director of the Committee in 1982 and Deputy Chief of Staff to the Senate Majority Leader in 1985. Ms. Burke served as a member of the Medicare Payment Advisory Commission from 2000 to 2007, and a member of the Board of Trustees of the Kaiser Family Foundation, from 1999 to 2008 serving as Chair of the Board from 2005 to 2008.

Ms. Burke serves on the boards of The Chubb Corporation and WellPoint, Inc., is a member of the Kaiser Commission on Medicaid and the Uninsured, the Board of Visitors of Georgetown University's School of Nursing and Health Studies, a member, Board of Directors, Association of American Medical Colleges, as well as a member of the board of The Partnership for Public Service. She was elected to membership in the Institute of Medicine, National Academy of Sciences in 2004 and to the National Academy of Public Administration.

Ms. Burke, a native of San Francisco, resides in the Washington, D.C. area. She earned a Master's Degree in Public Administration from Harvard University in 1982 and a Bachelor's Degree in Nursing from the University of San Francisco in 1973. She was awarded an Honorary Doctorate in Military Medicine from the University of the Uniformed Health Services in 1999 and an Honorary Doctorate of Humane Letters from Marymount University in 2005.

Early in her career, she worked as a staff nurse in Berkeley, California.

Keynote Speaker, Keith Flaherty, MD



KEITH FLAHERTY, MD, MASSACHUSETTS GENERAL HOSPITAL CANCER CENTER

The goal of our group is to understand the molecular and clinical consequences of inhibiting oncogenes and oncogenic pathways in melanoma with the aim of establishing individual approaches as therapies and constructing rational combination therapies.

Advanced melanoma remains a largely incurable diagnosis with a small subpopulation of patients who derive long-term benefit from immunotherapies and BRAF inhibitors. The availability genetic evidence and emerging experimental evidence provides a matrix of oncogenes and signal transduction pathways that have yet to be exploited in terms of development of targeted therapies. BRAF mutant melanoma represents a large subpopulation for which single-agent oncogene targeting has been established and the focus is now to

understand the consequences and limits of BRAF inhibition as a way of developing rational combination therapy regimens. Given that 50% of advanced melanoma patients are BRAF wild-type establishing foundation of single-agent or combination targeted therapies in this large and heterogeneous subgroup is a current unmet need. For BRAF mutant patients, the goals are to circumvent mechanisms of de novo and acquired resistance.

Our group is embedded within a network of laboratories, pathologists and nuclear medicine collaborators with a shared focus on melanoma translational research. Our goal is to maintain a portfolio of clinical trials with novel, targeted therapies to validate points of vulnerability nominated by preclinical investigations. In the context of those trials, we are focused on acquiring tumor biopsies to validate the molecular mechanism of each novel agent. Given the inability to safely biopsy all patients on research protocols, we are equally focused on credentialing blood-based biomarkers and novel non-invasive imaging methods for establish proof-of-mechanism and understanding heterogeneity in molecular response. Interrogating patient tumor samples to establish the role of candidate biomarkers in determining responsiveness or resistance is the focus of bedside to bench translational studies. This approached has allowed us to define several novel features of BRAF inhibitor associated resistance factors and downstream consequences.

Dr. Flaherty received a Bachelor of Science from Yale University and medical degree from Johns Hopkins University. He trained in internal medicine at Brigham and Women's Hospital and completed a fellowship in medical oncology at the University of Pennsylvania. After 7 years on faculty at the University of Pennsylvania, Dr. Flaherty moved to Massachusetts General Hospital and Harvard Medical School to serve as the Director of Developmental Therapeutics for the MGH Cancer Center.

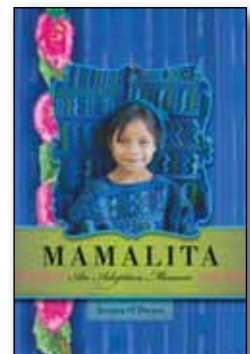
