We are making a concerted effort to upgrade and improve the ADA website. This is certainly long overdue. The new website will include more information about the organization, and importantly, there will be an interactive capacity to allow members to update demographic information (I for one am very dependent on the Membership Directory for contact information) and to make online payment of dues and easily register for meetings. In the execution of its enduring mission, it has been responsible for the development of other important dermatologic organizations including the American Academy of Dermatology; serving the vast majority of Dermatologists in the United States, and the Society of Investigative Dermatology, the preeminent organization representing research in Dermatology. Membership in the ADA is through nomination and election based on meritorious contributions to the field of Medicine and Dermatology.

The American Dermatological Association maintains a leadership role in the contemplation and implementation of initiatives that advance the field of Dermatology research and education and that in turn ultimately advances the care and treatment of patients with skin disease.



Actions of the Board of Directors

The ADA Board of Directors met on March 3rd, 2016 in Washington, DC. The following actions were taken:

- 1. Approved 13 new Active Members and 1 Associate Member and recommended 9 International Members to be voted on by the general membership.
- 2. Promoted 7 members to Senior Member status.
- 3. Approved the Call for Proposals and the new application format for the Resident/Fellow Research Award.
- 4. Approved the proposal for revamping the ADA website.
- 5. Approval of new voting procedure. All voting for new membership (International Honorary, Active, Honorary and Associate) be sent to the General Membership for voting simultaneously.

The ADA is pleased to announce its new Dermatology Resident/Fellow Research Award. Two individuals will be selected whose research is related to the integral nature of dermatology in medicine and issues leading to the marginalization of Dermatology. A Call for Proposal will appear in the April issue of JAMA Dermatology and has also been sent out to all ADA and APD members.


