Highlights



The 2017 meeting of the ADA will be focused on public policy and innovation in healthcare and medicine. Our meeting venue is the Fairmont Copley Plaza in Boston, MA, and the program theme is The House of Medicine: Developing an Institute of Dermatology. Our goal is to position the ADA as a coalition of thought leaders and authoritative advisors on issues of health and policy as they relate to dermatology, who can provide unbiased, evidence-based information and advice to policy-makers, professionals and leaders in every sector of society, and the public at large.

Keynote addresses will include presentations by Kathleen Sebelius, MPA, former United States Secretary of Health and Human Services from 2009-2014, speaking about "Healthcare in the 21st Century" and Victor Dzau, MD, current President of the National Academy of Medicine, former Chancellor of Health Affairs at Duke University and former President and CEO of Duke University Medical Center, who will be discussing "From Institute of Medicine to National Academy of Medicine: Serving as a Trusted Advisor to Health and Medicine."

This year's meeting will incorporate sessions on drug and medical device regulation and development, FDA regulation of compounding, and the prevention of skin cancer from a public health perspective. Each day will feature a multidisciplinary panel discussion focusing on challenging cases from the specialties of complex medical dermatology, pediatric dermatology, cutaneous oncology, and skin of color, along with a new "Best of the Derm Journals" session featuring the "Article of the Year". Taking the place of the introductions normally given at the New Members' Dinner will be a new feature, "Meet the New Members in Five Slides or Less," which will provide brief, targeted glimpses into the professional lives and interests of our newest class of inductees.

Invited speakers will also include:

Markham Luke, MD, PhD, is the current Director of the Division of Therapeutic Performance in the Office of Research and Standards at the FDA's Office of Generic Drugs; formerly, he was Chief Medical Officer and Deputy Office Director in the Office of Device Evaluation (ODE), Center for Devices and Radiological Health. His topic will be "FDA and Dermatologic Public Health: From Medical Device Regulation to Drug Access—The Juxtaposed Role of Good Science and Good Regulation."

Michael G. Kauffman, MD, PhD, is the current CEO of Karyopharm Therapeutics, Inc.; previously, he was Chief Medical Officer of Onyx Pharmaceuticals and Proteolix Pharmaceuticals. Dr. Kauffman's company's goal is to foster scientific creativity with pioneering technologies, whose focus is on novel drugs targeting the nuclear pore complex for cancer, inflammation, viral diseases, and other disorders of cellular proliferation. His talk is entitled "Development of Novel Drugs for Neoplastic Diseases."

Natasha Pattanshetti, JD, MPH, currently is the Manager of Regulatory Policy for the American Academy of Dermatology Association. The title of her talk is "Changing Landscape of Compounding Regulations," focusing on legal issues related to the use of compounded medications in practice.

FDA and Dermatologic Public Health: From Medical Device Regulation to Drug Access – The Juxtaposed Role of Good Science and Good Regulation Markham Luke, MD, PhD



Markham Luke, MD, PhD, is the Director of the Division of Therapeutic Performance in the Office of Research and Standards at the FDA's Office of Generic Drugs, which facilitates generic drug development through research and establishes standards to ensure therapeutic equivalence of new generic drugs. His interests include clinical study design, endpoints assessment (including patient-reported outcomes) for medical, surgical, and aesthetic products, and medical product development for rare diseases and special populations. From 2008 to 2016, he was Chief Medical Officer and Deputy Office Director in the Office of Device Evaluation (ODE), Center for Devices and Radiological Health. He was also Center liaison for Emergency Preparedness and senior

champion for regulation of UV indoor tanning devices. Born and raised in New York City, he majored in Biochemistry at New York University, obtained his MD degree at Johns Hopkins University, and completed his PhD under Professor Donald S. Coffey in Pharmacology and Molecular Sciences. He was a dermatology resident at Washington University/Barnes Hospital, St. Louis, MO. He served as PHS Fellow and Clinical Associate for Dermatology at the National Cancer Institute, NIH, then as Medical Officer reviewer in the FDA Office of New Drugs. In 2001 he became Lead Medical Officer for dermatology at the FDA. He currently serves as an attending at Bethesda National Naval Medical Center (now Walter Reed Medical Center), instructor at the Uniformed Services University of the Health Sciences, and as a medical consultant for the NIH.

Atopic Dermatitis in Adults: Not Just Big Kids Jonathan Silverberg, MD, PhD, MPH



Jonathan I. Silverberg, MD, PhD, MPH, is Assistant Professor of Dermatology, Medical Social Sciences and Preventive Medicine at Northwestern University Feinberg School of Medicine in Chicago, IL. He is founder and Director of Northwestern Medicine's Multidisciplinary Eczema Center and Director of the patch testing clinic at Northwestern Memorial Hospital. He received his doctorate in neuroimmunology, medical degree, and Master of Public Health degree in biostatistics and epidemiology from the State University of New York Downstate Medical Center in Brooklyn, where he also completed his internship in internal medicine. He did his residency training in dermatology at St. Luke's-Roosevelt Hospital Center and Beth Israel Medical Center in New York, NY.

Dr. Silverberg's clinical subspecialty is inflammatory skin disease, particularly atopic and contact dermatitis. His research interests include dermato-epidemiology, health services research, patient-reported outcomes, comorbidities and burden of inflammatory skin disease and evidence-based dermatology. His publications include over 200 peer-reviewed articles, abstracts, books and book chapters. He has been a local and/or national principal investigator for numerous clinical trials for novel treatments in atopic dermatitis and other inflammatory disorders. He received the inaugural Rajka Award from the International Society for Atopic Dermatitis in 2014.

Kathleen Sebelius is one of America's foremost experts on national and global health issues, human services, and executive leadership. As CEO of Sebelius Resources LLC, she provides strategic advice to companies, investors, and non-profit organizations. Sebelius serves on the Board of Directors of Dermira, Grand Rounds, Hampton Creek, Humacyte, the Kaiser Family Foundation, and Myovant Sciences. She co-chairs the Aspen Institute Health Strategy Group and serves on advisory boards for the Dole Institute of Politics, Solera Health, Out Leadership, and the Estée Lauder Foundation. From April 2009 through June 2014, Sebelius served in President Barack Obama's cabinet as the 21st Secretary of the Department of Health and Human Services,

where, she worked to pass and implement the Affordable Care Act. At HHS, Sebelius managed 11 operating agencies, 90,000 employees in 50 countries, and a \$1 trillion budget. Forbes named Sebelius one of the 100 most powerful women in the world. Having served as Governor of Kansas from 2003 to 2009, Sebelius is the only daughter of a governor to be elected governor in American history; her late father, John Gilligan, was Governor of Ohio. *Time* magazine named her one of America's Top Five Governors. Previous elected offices include two terms as the Kansas insurance commissioner and four terms in the Kansas Legislature. Sebelius earned a Master of Public Administration degree from the University of Kansas and a Bachelor of Arts degree from Trinity Washington University. She is married to Gary Sebelius, a federal magistrate judge. They have two married sons, Ned and John, and two grandsons, George and Hugh.

m From Institute of Medicine to National Academy of Medicine: Serving as a Trusted Advisor to Health and Medicine Victor Dzau, MD Introduction by Eugene Bauer, MD **GRAND BALLROOM**



Victor Joseph Dzau, MD, is President of the National Academy of Medicine. Born in Shanghai and reared in Hong Kong, he is an internationally acclaimed leader and scientist whose work has improved health care in the United States and globally. Under his direction, the National Academy of Medicine/Institute of Medicine advances research and improves health by providing objective, evidence-based guidance on critical issues. His foresight in translation of research into diagnostic methods, medicines, and creative solutions for human health issues is a great asset to the Academies and to the public at large. His own research laid the foundation for development of angiotensin-converting-enzyme (ACE) inhibitors, used globally to treat high blood pressure and

congestive heart failure. He pioneered gene therapy for vascular disease and was the first to introduce DNA decoy molecules to block transcription as gene therapy in humans. He is a member of the board of directors of the Singapore Health Services, a former member of the Advisory Committees to the Director of U.S. National Institutes of Health and the International Review Board of the Canadian Institute for Health Research. He chaired NIH's Cardiovascular Disease Advisory Committee and is past chair of the Association of Academic Health Centers. In 2011, Dzau led a partnership among Duke Medicine, the World Economic Forum, and McKinsey & Co. to establish the International Partnership for Innovative Healthcare Delivery.

Prior to becoming President of the National Academy of Medicine, Dr. Dzau served as Chancellor for Health Affairs and President & CEO of Duke University Medical Center. Earlier academic appointments include serving as the Hersey Professor of the Theory and Practice of Physic (Medicine) at Harvard Medical School, Chair of Medicine and Director of Research at Brigham and Women's Hospital, and Arthur Bloomfield Professor and Chair of Medicine at Stanford University. He has received numerous awards including the Max Delbruck Medal from Humboldt University Charite and Max Planck Institute, the Gustav Nylin Medal from the Swedish Royal College of Medicine, the Polzer Prize from the European Academy of Sciences & Arts, the Ellis Island Medal of Honor, and the Distinguished Scientist Award of the American Heart Association. Dzau received his undergraduate and medical degrees from McGill University.

The Museum houses an art collection of global importance, including significant examples of European, Asian, and American art, from paintings and sculptures to tapestries and decorative arts. In 1990, thirteen of the Museum's works were stolen; the high-profile crime remains unsolved, and the missing artwork's location is still unknown.

Joseph C. Kvedar, MD, Vice President, Connected Health, Partners HealthCare, is creating a new model of healthcare delivery, developing innovative strategies to move care from the hospital or doctor's office into the day-to-day lives of patients. Under Dr. Kvedar's leadership, Partners Connected Health is helping providers and patients better manage chronic conditions, maintain health and wellness, and improve adherence, engagement and clinical outcomes. He is also a board certified dermatologist and Associate Professor of Dermatology at Harvard Medical School.

Dr. Kvedar is the author of <u>The Internet of Healthy Things</u> describing how everyday objects will capture and use real-time biometric data to ultimately change behavior to improve health. Dr. Kvedar is internationally recognized for his leadership and vision in the field of connected health and has authored over 100 publications on the subject. His popular cHealth Blog provides his insights and vision for connected health. He contributes to a number of publications including *the Journal of the American Academy of Dermatology, JAMA Dermatology* and *the Journal of Investigative Dermatology*. Dr. Kvedar is a past Chair of the American Academy of Dermatology (AAD) Task Force on Telemedicine.

Development of Novel Drugs for Neoplastic Diseases Michael Kauffman, MD, PhD



Michael G. Kauffman, MD, PhD, co-founded Karyopharm with Dr. Sharon Shacham in 2008 and has served as President and Chief Executive Officer since January 2011, as Chief Medical Officer since December 2012, and as a director since 2008. Prior to joining Karyopharm, he was Chief Medical Officer of Onyx Pharmaceuticals Inc., after it acquired Proteolix Inc., where he had been Chief Medical Officer since 2008. At Proteolix, Dr. Kauffman led the development of Kyprolis (carfilzomib), a novel proteasome inhibitor approved for refractory myeloma by the FDA in July 2012. Prior to joining Onyx Pharmaceuticals, Dr. Kauffman was an operating partner at Bessemer Venture Partners, where he led investments in biotechnology companies and served as President and Chief

Executive Officer of Epix Pharmaceuticals, Inc., a biopharmaceutical company that underwent liquidation proceedings in 2009. He led the merger of Predix Pharmaceuticals, a private biopharmaceutical company focused on G protein-coupled receptors (GPCR)s, and Epix Pharmaceuticals, where he oversaw the discovery and development of four new clinical candidates and led collaboration transactions with Amgen and GlaxoSmithKline. Dr. Kauffman currently serves on the board of directors and compensation committee of Verastem, Inc., a public biopharmaceutical company, and on the board of directors and the compensation committee of Metamark Genetics, Inc., a private molecular diagnostics company. Dr. Kauffman received his B.A. in Biochemistry from Amherst College, his M.D. and Ph.D. from Johns Hopkins Medical School, and trained in internal medicine and rheumatology at Beth Israel (now Beth Israel Deaconess Medical Center) and Massachusetts General Hospitals. He is board certified in internal medicine.
